### Dale Cottages Inc. The First 50 Years

### **Forward**

This updated story celebrates the first fifty years in the life of the Dale Cottages at Armadale. It is a valuable supplement to an earlier book written by Jack Murray, the long serving Chairman of the governing board from March 1957 to March 1995.

Long term supporter of Dale Cottages, David Allen, with assistance from Kim Fletcher, has created a version that speaks not so much about the cottages themselves, as about the people who have given so much of their time, to the group of volunteers and staff who provide the day to day roof over so many heads. They have done so in an exemplary manner, while also being flexible and far-sighted enough to be able to ride the huge changes that have occurred in the care of seniors over the last 50 years.

The story of Dale Cottages in many ways mirrors that of Armadale itself: one of growth, in the belief that in doing so it should provide the complete range of

services for its residents without them having to turn to strangers in distant places. Thus has ensured a balanced, socially sustainable community that has remained in place amongst friends, family and familiar surroundings. (Not all of us want to rush off to the beach in our retirement.)



### Mr. John Edward Murray JP BEM (1911 - 1999)

Widely recognised as the founding force of the Dale Cottages (Inc.)
Genially known as Jack, he came to farm in Armadale in 1943.
He brought with him a remarkable spirit of civic service developed when left to fend for himself in Manjimup after the deaths of both his parents while he was still a teenager.

This community spirit and endeavour remains through Jack's record of 16 years of service in local government (5 years as president) at a time when many of the district's facilities were initiated. But Jack's leadership and support of Dale Cottages and the naming of the

J. E. Murray Home in his honour will always remain his most rewarding legacy to our district.

### A Special and Important Acknowledgement

The content of this booklet has to a very considerable extent been influenced and facilitated by the book "The History of the Dale Cottages" written and produced by Jack Murray back in 1990. It has proved to be a highly valuable and valued resource in putting together "Dale Cottages Inc. The First 50 Years" commemorative booklet.

In many respects this present publication is simply a new, more contemporary version of the original, but of course updated to cover the 20 years that have elapsed since the earlier booklet was published.

That Jack's efforts came to fruition was apparently very much due to his family's encouragement and persistence. Much of it was dictated to one of Jacks' daughters, who recorded it all in shorthand, and then sat down and typed it out ready for the printer to do his work. Throughout the earlier sections of our booklet, many of the lists, images and documents have been directly copied (often in reduced form) and the factual content of our accompanying text was very dependent on the information put together by him.

It would be very remiss of us not to express our sincere appreciation to Jack Murray for the effort he made in recording the happenings in those formative years of the Dale Cottages (Inc).



### A word before we begin....

1954-59

This year's celebration marks the 50th year of providing housing for our district's elderly citizens: but certain preliminaries must first be recalled. The story of Dale Cottages had its beginnings arising from social conditions within Western Australia following the 1930s depression and the five years of World War 2. Housing in general was in short supply, but two sections of the population were particularly disadvantaged - returning exservicemen, anxious to resume domestic life found that only shared houses, converted verandahs, garages or other high priced unsuitable housing was all that was available to them, while at the same time many retirement aged pensioners were in a similar position having been unable to provide themselves with a home during their working lives.

In the Perth Metropolitan area a community minded politician, Mr. Richard Cleaver, Member for Swan, took up the cause of his aged constituents, taking advantage of federally available funds to establish what was to become the Swan Cottage Homes (now known as Swan Care Group) in Bentley. In our lower South-West a similarly urgent need was evident: timber workers who had spent their lives living in milling company-provided cottages found that upon retirement those homes were no longer available to them and they had to move on, but where? So, in Manjimup, another community minded citizen took up the challenge of this local need, resulting in the establishment of their Dunreath Cottages.



At the same time, in Armadale, a similar need had been identified where brick industry and rural workers were left upon retirement with no suitable housing. Indeed, the plight of one couple living in a condemned shack in very poor condition on the outskirts of the town was brought to the attention of members of the Armadale-Kelmscott Road Board in the early 1950s.

Although enquiries were made from other sources to assist the couple, it so happened that one of the board members, Mr. J. E. (Jack) Murray, had personal connections with Manjimup and those responsible for the establishment of their Dunreath Cottages, and in due course particulars of how that scheme had been put in place were presented by Mr. Murray to the Board on 20th September 1954 at a meeting of the Health Committee, a standing committee of the Armadale-Kelmscott Road Board. Strong support for the idea was given

by his fellow members and a motion was passed to investigate possible sources of funding which might be available to get such a project up and running in the Armadale-Kelmscott district. The investigations obviously brought positive and encouraging results and these led the Board to call a public meeting in the Armadale District Hall on the 6th August 1956 with business listed as:- "To inaugurate a Scheme for the provision of Homes for Aged Persons, within the District". The meeting was attended by "about 70 residents".


Mr. Murray at the Board's request submitted a Report on the Dunreath Cottage Scheme now in operation at Manjimup.

Following the election of a Steering Committee there appears to have been no shortage of enthusiastic and energetic townspeople to embrace this prospect. Immediately a Homes Appeal was formed under the leadership of Mr. E. G. McDonald, Manager of the local branch of the Bank of New South Wales (now Westpac) and fundraising began with a house-tohouse "doorknock" raising an initial £669/5/7d (\$1338.55) on one afternoon from 750 families throughout the district. It had been suggested that each household donate ten shillings (\$1.00). Subsequent fundraising involved many community organisations and activities including street stalls on the Co-op corner in Armadale and in Byford (then part of the Armadale-Kelmscott Road Board), auctions and admission fees from picture nights at the District Hall were donated by the operator Mr. Perrie.

During March 1957, the name Dale Cottages as proposed by Mr. Bernie Gibbon and Mrs. Jessie Thatcher, had been adopted and a Committee

of Management appointed. There were seven members from local organisations, two represented donors to the funds and the one appointed by the Armadale-Kelmscott Road Board as their delegate was Mr. Murray. When Mr. McDonald resigned as the Cottages chairman, Mr. Murray was elected as his replacement, and immediately began the process of making the project a reality.


A Certificate of Incorporation was issued on 29th July 1957 and the Committee quickly set about establishing its goals


and organisation so that by early 1959 land had been obtained upon payment of £1 to the Road Board for a portion of land in John Street which had been forfeited through non-payment of rates. This £1 was subsequently donated by Mr Ray Blackburn. Accumulated funds had now reached £2190 and necessary Government approvals for subsidy had been obtained so that a start could be made.

Local building contractors, Green and Saw were the successful tenderers to build a brick and tiled double unit, designed by Mr. E. J. Burrows, the Health and Building Inspector of the Road Board. The cost was £2870/0/0. A Lotteries Commission grant assisted with the provision of built-in cupboards, wood stoves, septic tanks, laundry (external and shared), floor covering and window treatments.

The ground work had now been done..... The value of this enterprise was about to unfold.



Boar Sir or Madam,

At a meeting of Delegates from District Organisations held on 24th September, it was decided to Imunch an appeal to finance the erection of homes for Aged People. It was agreed to ank for a denation of 10/- from each adult person resident in the Bood Board District, although larger amounts would of course be welcomed. To those who may find 10/- too such to give in one sum, we suggest that the amount could be contributed in instalments.

Our target is £3,000 and you will realise that this will only be reached with the wholehearted support of all in the district.

The week-end 10th-12th November has been chosen for the main collecting drive and a collector will call on you on one of those days. He will carry a letter signed by the Chairman and Secretary of the Committee, authorising him to receive donations. Your contribution will be entered on a denation list, but if an efficial receipt is required, please motify the collector and one will be forwarded to you.

Donations will be allotted to the areas from which they are received, and as far as precticable, homes will be erected in each district where sufficient mesey is raised. It will be appreciated that people who may require assistance would be very much happier if housed in the vicinity of life-long assistance would be very much happier if housed in the vicinity of life-long associations, remaining among friends and relatives, instead of having to reside in a stronge area in localiness and isolation. However that happiness brought to men and women in the eventide of their lives is comething not easily to be measured in terms of cash.

There may be married pensioners who have insufficient money to build a home under prepent conditions, who may be prepared to assist by denoting a substantial sum which would give them the sale right to occupy a home so long as either may live.

The total sum raised by this appeal will be matched by an equal amount which has been promised by the Social Services Department. It is hoped that the Lotteries Commission will come in on the same basis, so that if our target of £5,000 is reached it will result in £9,000 being awailable for building.

We are sure that you will agree that this cause is worthy of your support. One of these homes might selve a problem for you in the years to come.

He has kept both myself and the officers of my Department in touch with the progress of the work being done at Armadale and I could think of no more appropriate person to be associated with the official opening.

From 50 years forward we can only imagine the sense of achievement, satisfaction and district pride which would have pervaded at the opening of the first cottage pair on Sunday October 11th 1959. Mr. L. W. Hamilton, representing the Minister for Social Security, the Hon. Mr. Wentworth performed the ceremony in the presence of many political figures and local supporters including 100 friends and helpers from the district. "It was a proud moment for me when Mrs. Webster and Mr. and Mrs. Bingham were handed over the keys to the first cottage" said Mr. Murray in a later interview. A weekly charge of 25 shillings (\$2.50) gave them security of tenure for the remainder of their lives.

There now followed a period of continued building activity with the construction of units endeavouring to keep pace

with the growing number of prospective tenants. By 1966 Lots 169, 170 & 171, at the bottom of John Street, purchased from the Road Board for

a very nominal cost all had duplex units built on them.

Expansion required more land, which fortunately lay right at hand - the adjacent old brickworks site. One of the first industrial undertakings in the area, the Armadale Brickworks had been established in 1903 and had operated continuously until 1929 but over the intervening thirty years it had remained an abandoned conglomeration of crumbling kilns, untidy gravel pits, rubble mounds, stagnant ponds and some remnants of the brick making process: a tall brick chimney stack, rusting machinery, the manager's house (the garden grape vine of which is still there) and of great interest, the head-frame and winding gear of the unique contrivance which brought the clay and shale down from the also abandoned quarry near Bedfordale Hill Road. This site would have presented a huge challenge to any real estate developer, but as it was seen to be so suitable by those who were considering the needs of our aged, the land was acquired and now forms the greater area of the Dale Cottages grounds.

Landscaping plans to overcome the inhospitable nature of the surroundings were prepared by Oldham, Boas, Ednie Brown and Partners. This allowed for the highlighting of the winding gear

within a dedicated garden setting, as well as the internal roadways and what is believed to have been the first for WA, a locality of underground power connection.

With 3 cottages now erected on John St, the embryo of what was to develop into a flourishing complex of homes for the aged had been well established.

The cottages built in this area behind John Street were now designed by the state Housing Commission and all built by B.N. Holmes. Connection to the Metropolitan Water and Sewerage Board's system enabled the individual leach drains of

earlier units to be up-graded; a higher capacity of electric power switch room was needed and around this time residents had been granted permission to erect their own laundries if they wished at their own expense! This was a time when Armadale remained rather rural in character. The original convenors of the Dale Cottages scheme maintained their commitment and enthusiasm under the leadership of such persons as Jack Murray and Carl Rodgers who were to play such vital roles over an extraordinary number of


the Secretary's position for the vital first 10 years, retiring in 1965 when his place was taken by Mr. K Sharp. Other Committee changes of this period included the appointment of Mr. L Hughes as auditor, replacing Mr. C Marsh, Mrs. L Ridoutt replacing Mr. R Thompson and the place of RSL representative, Mr. D Cumming being filled by Mr. R (Dick) Wilson, who remained on the Committee (later becoming Vice President and Secretary) for 24 years. By the close of the 1960s a further one and a half acres










Drawings from plans prepared late 1964 for the construction of the third cottage on Lot 169 John Street.




Foundation works of the J.E. Murray Home under construction 1974.


By 1970, a wider need for comprehensive Aged Care facilities was commanding attention throughout Australia. At our local level, the Dale Cottages provision for that need was firmly established and indeed, well equipped to accept the challenges of allowing our own aging residents stay close to home in their declining years. Significant developments were completed during this next decade, the most valuable of which was the building of the long awaited frail persons hostel. Land in Deerness Way had previously been




1971 plan of Dale Lodge, a double storey building, the first to be erected on the Dale Cottages site.

purchased with this in mind. In 1974 the 38 bed hostel, again with Bert Holmes as builder and at a cost of almost \$400,000 was up and running. Planned with much assistance from the Extended Care section of the WA Health Department, the hostel represented all desirable features of a contemporary hostel for its purpose. In the words of Mr. Carl Rodgers "It has been designed to cater for frail-aged people who could still walk and look after themselves, but needed someone to make sure they cared for themselves". Admission to the hostel at this stage was largely voluntary and families eagerly embraced the opportunity to keep their elderly relatives close to home for as long as possible. The Armadale-Kelmscott Shire Council had assisted with finance for the furnishings and Mrs. Diana Murray and Jack's family were of great help in the choosing and application of the interior décor. Local commitment continued from a fund-raising committee led by Mrs. Marjorie Smith providing many amenities including our first (colour!) television, as well as setting up a conveniently located kiosk to cater for residents' minor shopping needs which it has now done over the past 35 vears. As well as continuing to build cottages, two ventures into higher-density and two-level units were undertaken. Dale Lodge, facing Eleventh Road (now Hobbs Drive) was completed during 1972, providing 40 units (flats). This block was designed with shallow ramp access to upper areas and to sheltered internal courtyards. With shared laundry facilities supplied with hot water space was saved within the units. The weekly service charge was now \$3.50.





Opened in 1979, Rodgers Court was a more modest undertaking. These 10 units were built completely self contained and for the first time resident car-ownership and parking needs were recognised within the planning, with a nearby block of 10 brick, lock-up garages provided. Hitherto, as car ownership among residents had gradually become more common, small groups of rather incongruous asbestos garages had sprung up in spare corners of land, often at an inconvenient distance from the resident using it.


By 1973, a small parkland had been developed in the centre of the complex encircled by Law Crescent. The site (once part of an earlier gravel pit) contained a large fishpond with a bridge over it and a fountain as well as facilities for lawn bowls. Native trees had been largely retained at this stage (sadly, most of the marri red-gums have since had to be removed) making the grounds quite a show place, popular as a backdrop for wedding photos and earning a second place in the 1977 section of the Keep Western Australia Beautiful competition. Activities within the Senior Citizens Hall built within our estate by the Shire Council, proved a great asset in helping supply many recreational needs of our residents.

Of course such a growing enterprise could not continue to be run entirely by volunteers, dedicated though they continued to be. Operating the JE Murray Home required the appointment of a Supervisor supported by a number of semi-professional and caring staff, with a consequent increase in financial accounting and record keeping. Mr. Beales continued his fortnightly walks around the "village", knocking on doors

and collecting, in cash, the service charges as well as maintaining invaluable contact with individual residents. (Collecting the cash payments of service charges was to continue until 1993 when it was deemed that the lone female staff collector could have been somewhat put at risk). Mr. Murray attended daily to manage the General Accounts until Mrs. Eileen Snow was engaged in 1975 to keep the office records in an ad-hoc space (intended as a minor treatment room) in the new hostel building.

Prior to this time, any business affairs as well as Committee meetings had been held in the Armadale District Hall, the Lesser Hall, the Infant Health clinic, the old Road Board office and some officers' residences. The activities room in the new hostel then provided ideal space for Committee meetings over the next fifteen years. Outside matters also required that staff be engaged. From 1974, a caretaker position was created. Mr. F Kempton and Mr. K Priddle were early appointments.

### Consolidation... Achieving a well established and distinctive place in the community.





How Armadale and surrounds had changed by the time we moved into the 80s! Gone were the small orchards, piggeries, dairies and poultry runs of west Armadale and Kelmscott (and with them the confusion of numbered roads and avenues) to become the broadacre lots of 'instant' housing, new schools and new neighbourhoods. The pleasantness of living in the foothills of the Darling Range had seen the Canning valley and Roleystone surrender many rural aspects to semi-rural developments. This swelling of population resulted in the old Armadale-Kelmscott Road Board morph into firstly the Shire of Armadale-Kelmscott in 1961, then the Town, 1967, and finally the City of Armadale in 1985. The particular environs of the outer Metropolitan hills areas, especially from Kalamunda to Armadale seemed to have an attraction for more-elderly English migrants who had been influenced by the enthusiastic reports of their younger families who had come to Western Australia in the 1960s and 70s. So it was that during this period, the complexion of applicants for accommodation at Dale Cottages was no longer predominantly of local relationship, but included many from England. These blended happily into the lifestyle offered. The diverse talents, interests and energies of the now-substantial community are reflected in the wide range of activities which

have flourished within the village and the Senior Citizens Centre: carpet and lawn bowls, art classes, co-operative insurance, coach tours, a monthly news sheet "The Dale News", keep-fit sessions, and perhaps many more. Meanwhile, the Dale Cottages site continued to expand. On land fronting Streich Avenue (Hobbs Drive) purchased from a local medical practitioner, Dr Noel Colver and his wife, supplemented by an adjacent area purchased from the Town of Armadale, a new 16 unit, town-house style project

was proceeding. The design plans were again prepared by Oldham, Boas Ednie Brown, with Bert Holmes continuing as our builder, who at that stage had built all our buildings, apart from the first duplex. This Federation style group of housing was opened in 1984 by Mr. R (Dick) Wilson, Vice President and RSL representative since 1966, for whom it was named 'Wilson Place'.











### The Homes that Holmes Built


It comes as no small surprise to realise that so much of what constitutes the present physical presence of the Dale Cottages complex has been due to the contribution of one man and his construction business. Bert Holmes was responsible for building of all but one (the very first) of the duplex cottages erected on the site. But not only that, four major blocks of buildings, Dale Lodge, J.E. Murray Home, Rodgers Court and Wilson Place were also constructed while the cottages continued to be built during the period 1964 to the beginning of the 1990s. By the mid 90s other construction concerns were contracted to carry out the most recent building projects. The last work to be done by the business of B.N. Holmes, carried out in 1998, was to enlarge and re-model the cottage at 1 Law Crescent (see photo above), the home of Mr. & Mrs. Ken Thomas (Mr. Thomas was a RSL representative on the management committee in 1995).


Some committee changes were also taking place. After eighteen years' outstanding service as secretary, as well as acting as right hand man for Jack Murray, Mr. Carl Rodgers decided to call it a day. Mr. Rodgers who had been actively involved in many of the organisation's negotiations for land acquisition, grants, subsidies and services (and favours) was deservedly awarded the first Honorary Life Membership of Dale Cottages upon his retirement in 1988. The overall composition of the Committee was also changing - replacements were sought from civic minded residents of the district as by now, thirty years on, many of the organisations which had provided the original complement of members had ceased to be active, exceptions being the City of Armadale, the Rotary Clubs (now three) and the local sub-branch of the R&SL which all continued to provide representatives of valuable support. At this time, one of our ex-employees, Mrs. Eileen Snow was also a committee member. Mrs Snow had been the first administrative appointment, but during the 1980s the daily attendance of Jack Murray and Dick Wilson could not adequately cope with the banking, record keeping and other growing administrative duties so a part-time office staff of three young ladies had been recruited to provide, in Jack's words "a happy and sincere service to all". The J E Murray Home, now fifteen years old had been given several up-grades to keep pace with the improving standards of Aged Care. Benefits flowed from a modern inter-communications system, better access to toilet and shower areas, improved fire and emergency protection and automatic operating entry doors. All this came at a cost totally borne by the organisation, somewhat to the concern of the Committee whose "nest-egg" of accumulated funds had been jealously guarded towards the erection of that much desired goal, the Nursing Home. This ambition was now of necessity delayed. By the close of the 1980s Dale Cottages property was valued in excess of \$6M. This consisted of 6.5ha of land, 74 units, a 38 bed hostel, all accommodating 275 residents. There were now 17 employees, residents paid an entry fee of \$3750 and paid a weekly service fee of \$7, (still collected weekly by hand, by a junior part-time office employee, Mrs. Trudi Hodges). Alan Cowburn, appointed in 1982, a position he still holds in 2009 as Dale Cottages' longest serving employee, well over 25 years.

## Onto better and Greater Things ... Pushing boundaries and dealing with demons

For much of this decade, the matter of providing a Nursing Home (now to be known as a Residential Care Facility) was to occupy much of the Committee's time and energy. Long was the period of heart-aches associated with the loss of each infirm resident who had to be transferred out of the J. E. Murray Home away from family and friends as they needed more specialised care which could only be provided elsewhere. Throughout the latter part of the 1990s relentless lobbying was undertaken with Government departments and politicians of all persuasions, the most helpful of whom were our Federal Member, Ricky Johnston and State Members Kaye Hallahan and Alannah MacTiernan. Only after a campaign including a petition signed with over a thousand names had been presented in Canberra in January 1998, and a capacity crowd at a public meeting in the Senior Citizens Hall expressed the district's strong support for this cause, did we achieve an allocation of beds.

This allocation was smaller than anticipated and was insufficient to maintain a separate establishment as had been hoped, but which then necessitated a complete change of plan: the existing J.E. Murray Home would have to be enlarged. However the land required to provide this enlargement gave us quite a problem in overcoming some local opposition to acquiring a small part of Alderson Park for the purpose. Finally, on October 22nd 1999 Mr. Murray was able to ceremoniously turn the first sod for the construction of a twenty bed extension to the J. E. Murray Home, thus realising a personal passion as well as the worthy ambition of the Armadale District to care and provide for its senior citizens.

Despite the consuming distractions of these developments, there was much advancement around the wider estate during this period: more properties had been bought in Deerness Way. The house at No. 18 was used as the administration centre for some time, while other houses were destined for eventual demolition; the Hills Medical Centre was bought, modernised and re-leased to the doctors, in catering for the contemporary demands of more-affluent retirees, two-bedroomed cottages were now being built where re-development opportunities occurred, there was a progressive modernisation of kitchen, bathroom and service areas of other units.







### A succession of leadership changes in the 1990s.

With the retirement of J. E. Murray in March 1995, after nearly 40 years as president, the Board saw in just 4 years, 3 changes in the leadership position, the incumbents being (from the top)

Mr. John Cumming 1995

Mrs. Eileen Snow 1999

Mr. Frank Green 1999

Mrs. Trudi Hodges, who was appointed to the very taxing and exacting position of Chief **Executive Officer of Dale Cottages** Inc in 1998, joined the office staff in 1987, as one of three young women who were employed that year, on a part time basis to help cope with the increasing administrative work load. In her role as C.E.O. increasing complexities associated with the proper running and development of a well functioning, well maintained modern aged care facility have been dealt with in the most efficient and determined manner. Her hard work was to see established in the decade to follow, a complex of a standard that would be difficult to better anywhere

Groups of asbestos - sheeted garages were replaced with steel structures; we now had a small bus to provide transport for private medical appointments, as well as allowing regular shopping and pleasure excursions; night patrols of security officers were put in place to deal with one of the down-sides of community development where spates of minor harassment were being experienced by some residents. The office now managed by the appointment of Mrs. Trudi Hodges as Administrator in 1993, even had a computer.

Accommodation in the existing J. E. Murray Home had been vastly improved with the effective conversion of all bedrooms into suites, including individual en-suite facilities. A State of the art system gave instant and direct fire alert to the Armadale Fire Station and the enlarged and handsome dining room and unique 'gopher' room were well in use. But there was much staff organising to be implemented with new requirements of the Aged Care Structural Reform Package of 1977 and its associated paper work and detailed record keeping, so that Carers felt (and still feel) that much of the time they had previously been able to spend with residents had been taken away.

A new ethic, that of supplementing our primary role of accommodation provider with a role of making a contribution to the welfare and lifestyle of the villagers was embraced by our enthusiastic and creative staff. Together with the Activities Officer from the Hostel they established an attractive calendar of events to stimulate and draw together all residents for fun occasions; the Annual Melbourne Cup days held in various locations around our grounds transported us to Middle Eastern, Oriental and other Fantasy Land race tracks; the 1996 mini-Olympics drew a visit from Mrs. Shirley de la Hunty who graciously brought her gold medals and commemorative torch; and who would have thought the stage of the Senior Citizens Hall would hold a 1940s style swing band of 12 musicians - but what a time we had at the Swing Ball; Quiz nights were well supported by faithful local sponsors; Christmas Carols at the appropriate spot of the bridge crossing over the lily pond... and numerous other opportunities for socialising were organised by our girls.

In March, 1991, Mr. Jack Murray (by now a JP, Rotary Paul Harris Fellow and BEM) while continuing to exert energetic control and leadership of Dale Cottages (Inc.), celebrated his 80th birthday. However, he decided to retire at the Committee's AGM in March, 1995, thus bringing to a close thirty eight years of un-broken leadership through the establishment and early development phases of this worthy enterprise. He continued to attend Board meetings in his capacity as Life Member.

The position of President was now taken by Councillor John Cumming, long-serving Committee member and Vice President, and whose father had been a member of the original committee. John will also be remembered, with his company AK Contractors, for undertaking the demanding challenges to be faced with the unstable and uneven levels of this most awkward of sites. His legacy of firm foundations, efficient drainage and roadway paving has contributed much to our solid buildings. However, by the end of this period, Mrs. Eileen Snow had served as President for a short time, until Councillor Frank Green assumed the position in 1999.

By now the whole aspect of aged care provision throughout Australia was changing enormously. The advent of the Retirement Villages Act of 1992, as well as associated welfare and safety regulations were imposing increasing pressures, making it impossible for our voluntary lay personnel to maintain effective oversight of daily procedures. To cope with these changed times, the Committee has become a Board of Management (with resident representation - a first, as far as we know) with the day to day management in the hands of a Chief Executive Officer. Having absorbed the background ethos and experienced Jack Murray's wise counsel over the previous eight years, there was none fitter to accept the task than Trudi Hodges. Trudi quickly assumed an ascendant role, assisting the Board keep abreast of all that authorities, and especially our Community were expecting of top-quality aged-care provision such

The conclusion of the decade saw the eventual passing of Jack, the generous and genial driving force of our organisation. His death on December 29th, 1999 was much mourned by us all - it was as though, having seen the fulfillment of the complete Dale Cottages concept, and feeling it was in good hands, he now felt his 45 year contribution was enough.

# 1999 - 2009 A great dream achieved... with a bright clear view into the future

Working through the final decade of this half-century of service has seen no slowing of dedication and purpose of our management. The adoption of a carefully considered strategic plan has ensured optimum development of this onceworthless and abandoned plot of land into an aged-care complex of inestimable value to the City of Armadale and surrounding districts.

No sooner were the first residents in place in the beautifully new 20 bed Jacaranda and Grevillea extension of the J. E. Murray Home, opened on November 25th, 2000, than the demand for additional residential places became even more insistent. Our response was to obtain the necessary licences and proceed with a most imaginative and effective two-level expansion on the western side of the Home. The absolutely generous donation from a local citizen Mr. Charlie Ramm, enabled this ambitious plan to become a reality, resulting in the handsome C. N. Ramm House giving superior accommodation, comfort and security to a further 20 residents and their families. This was opened in 2004.

Over the years, the number of frail, elderly citizens we were able to have in residential care doubled from the original 38 in 1974 (all low care) to 77 (14 low care, and 63 high care). The appointment of a Director of Nursing and fully-qualified nursing staff had now become a necessity. The overall staff number increased from 25 to 56 just during 2001! Conforming to accreditation standards had also become a necessary priority, and with it fresh demands into unknown territory. Our staff achieved the first three-year accreditation for the J. E. Murray Home in 2000.

We were now offering supplementary support services reaching outside our walls consistent with the Government's policy of Ageing in Place. These activities included delivering thirty Community Support Packages, promoting and managing our WISE centre for ancillary medical and personal services as well as managing the Greendale Centre for recreation opportunities, and catering from our own kitchen for the district's Mobile Meals.


Providing for our independent-living residents has also kept pace with the changing times. While the number of available cottages or flats has reduced slightly, the overall choice of unit style has improved dramatically to reflect current standards we believe our residents have a right to expect.

The lower Deerness Way area now has 15 two and a half bedroom cottages of contemporary design and fittings, while the latest project of converting out-dated cottages and ineffective open spaces along our John Street frontage has allowed consideration of environmental sustainability. The replacement cottages have been designed with solar hot water heating, water-wise gardens, quality insulation and northern orientation where possible. The conversion of Dale Lodge flats into gracious apartments has also been a popular move, again adding to the variety and choice of styles of accommodation on offer. At the same time, we have been able to maintain the long-held policy of reserving places for applicants without financial means, to obtain a unit on a rental basis with no entry fee. The provision of low-cost retirement accommodation in contrast to the current supply of up-market resort-style villages is now being seen as a future concern by the industry in general.

A sad note from this era records the loss of the brickworks remnants of the Armadale brickmaking industry, so long a landmark within our complex. Although prominence had been given to the winding tower and associated machinery as part of the Grove landscaping, there had been a history of many objections to its presence from residents of the day. This, combined with the prohibitive costs of restoration to safety and National Heritage standards led to the Board's decision to have the site cleared in 2000. The Board continues to work towards having the site provided with a suitable historical marker. Such a period of expansion and extension could not have been undertaken without an upsurge of activity from our community sponsors and supporters. The City of Armadale, the Armadale Rotary Club, and the Armadale Sub-branch of the RSL have maintained unbroken service, maintaining representation on the Board since Dale Cottages beginnings. The City, from its Road Board days has been un-wavering in ensuring all land and infrastructure needs are supported, as well as steering us through many local government and civic negotiations. The three district Rotary Clubs (Armadale, Kelmscott and Neerigen Brook) continue their proud record of material assistance ranging from providing supplies of firewood for the stoves and fireplaces of our original cottages through the 60s, donating bricks for a 1968 cottage, supplying both interior and exterior amenities for the Hostel and sharing the financing of both village buses and the personal transport car.

The RSL are always on hand for ceremonial events around the flagpole precinct which they provided and maintain. One of their associate-members, Kitty Wilson manned and directed the volunteer roster for the Hostel Kiosk for many years. Latterly, the Dale Cottages Foundation, formed by a group of enthusiastic workers has augmented the efforts of these other groups and assisted greatly in raising further funds for furnishings and other residential needs.

No record of assistance could be complete without reference to our volunteers. Many are the programmes and vital tasks carried out by these cheerful, supportive people. They drive residents to medical appointments, or shopping, or on excursions; they serve afternoon teas, provide entertainment keep the Hostel kiosk open and have even published an entertaining news sheet 'The Dale News' and have been on hand to help with many informal tasks, sometimes at a moment's notice. Many of these are drawn from our own residents and all add to the level of comfort and enjoyment of our elderly.

A severe blow at both personal and corporate levels occurred at the sudden and untimely death of Past-President and then current Board member, Frank Green during 2008. Frank had been a strong figure during some of this organisation's most complicated expansion phases and richly deserved his award (unfortunately posthumously) of Life Membership of Dale Cottages.

Now we come to note the current situation (2009):- A staff of 88 are engaged to care for 77 live-in residents, including a high proportion of high-care people, and we provide cottage, flat or apartment accommodation for 170 independentliving residents. With our Community outreach programmes we provide care and services to over 500 residents and clients. Our organisational revenue has reached \$5,000,000 (an increase of nearly 500% over the past 5 years) and our assets are valued at \$31,000,000. This has imposed staggering responsibilities on our Chief Executive Officer and her staff. The levels of accountability, both financially and professionally, as well as keeping abreast of developments within the Agedcare industry and anticipating the future needs of our people have all been dealt with in a manner giving confidence to the Board. This firm trust has been so vital since the hands-on operation of the initial committees and volunteers has of necessity taken new directions.










